Message from the President By John McDanel, AWCC President

"The been driving from one meeting about sprawl to another for fifteen years, and the only thing that's changed is that now it takes a lot longer to get there." - Rob Melnick

While the Western Ave project has been stopped by winter, the North Shore Connector boring machine completed the tunnel mining portion of the project. Most of Western Avenue and a good portion of Allegheny West will be within a half mile walk of the new LRT transit stop at Allegheny Ave. While not a panacea, it should be good news for our neighborhood and the Northside. According to Reconnecting America, 30 percent of the demand for housing is for denser, walkable, mixed-use communities, and less than 2 percent of new housing starts are in this category. Obviously, something went wrong in real estate - one could wonder if there was more to it than sub-prime lending. The Urban Land Institute argues that "the trick for real estate developers has always been identifying the hot transit system. Today, highways are out; urban transit systems are in."

At the national level, mass transit has gained traction with voters. In November, the Wall Street Journal reported that mass-transit projects fared well at the polls, with over 70 percent of mass transit projects getting approval from voters – about double the usual approval rate. Last summer, other changes were noted in the media, such as Christopher Leinberger of the Brookings Institution saying the American dream is changing. We will finally witness the beginning of the end of sprawl, he predicts.

The North Shore Connector project should be completed in 2011 at a total cost of \$552 million, and is 80% federally funded. The Port

Authority expects 4.2 million annual riders to use the North Shore Connector, and further expansion into the North Hills and other areas in Allegheny County. The Connector had its fair share of opposition from a group of politicians and various citizens. Recently Simon Property Group dropped plans for a sprawling mall complex in Cranberry because \$63 million in state and federal funds from road and highway improvements to the mall disappeared. Dale Pinkerton, chairman of the Butler County commissioners, said the project would have benefited Allegheny County. An attempt at humor? Many of the retailers we hoped would locate downtown, Nordstrom's for example, have leased space at Ross Park, another Simon property.

Be glad we got transportation dollars and Cranberry didn't. In his book Twentieth-Century Sprawl, Owen Gutfreund examined highway federalism and how it reshaped the American landscape. Gutfreund concluded:

The anti-urban slant of state and federal policies, the collapse of mass transit, and civic initiatives meant to accommodate cars undermined the sustainability of the city itself, fundamentally altering settlement patterns. Culture and technology were channeled and focused by the cumulative effect of subsidies that skewed personal and corporate decision making, underwriting sprawl while undermining urban density. The manner in which Americans adapted the national infrastructure to accommodate the automobile encouraged the dispersal of jobs and people across the continent and fueled a nationwide need for capital expenditures unmitigated by consideration of equity, efficiency or affordability. The drive to accommodate automobility, as the United States built far more pavement per capita than any other nation on earth, transformed all American communities, big and small, east and west, north and south.

Re-adoption of the Allegheny West 8 Year Plan

Motion:

AWCC hereby readopts the findings and recommendations of the Allegheny West Plan 2000 - 2008, including the Mary Means Report, while noting that at least some of the recommendations in the Plan have been implemented.

In particular, as recommended by the Housing and Planning Committee, AWCC should continue to work toward:

- development of residential uses in the 800 and 900 blocks of West North (as proposed, in part, in the plans for The Lofts project); such uses may be combined with some retail/office, as appropriate; the former A&P site and the Brighton – Western site should also be developed as residential;

- development of new commercial uses on undeveloped sites at the corners of Western and Galveston, Western and Allegheny and North Lincoln and Allegheny;

- development of a new parking structure on the north curb of Ridge in the 900 block between Allegheny and Galveston;

- development of residential uses in the 900 block of North Lincoln;

- development of residential uses on Ridge between Brighton Road and the railroad tracks; and

- development of links to the new LRT transit line.

AWCC should also work toward:

- growing businesses on Western;

- extension of HRC construction guidelines to all new construction areas, regardless of whether or not they are in the historic-designated district;

- more aggressive enforcement of prohibitions on surface parking lots in parking overlay district and monitoring of zoning to preclude additional surface parking;

- City enforcement of all code/parking regulations during events on North Shore, at City's, not Allegheny West's, expense;

- establishment of a comprehensive tree maintenance and replanting program;

- ensuring that timely and appropriate improvements take place in West Commons, working with the Commons Initiative;

- monitoring and elimination of "blight", inappropriate signage, and poor street cleaning, including storm sewer; and

- control of truck traffic through the neighborhood.
