## I. Reports of Elected Officials, City Departments, and Other Organizations

## A. City of Pittsburgh Zone 1 Police (Ofr. Defeo)

- Warm weather brings a rise in police report numbers.
- There were three police reports and one arrest in April.
- A business on the 900 block of Western Avenue was burglarized.
- An arrest was made at Lefty's Bar for defiant trespass, but the suspect's blood alcohol was too high for jail.
- Complaints about Lefty's have increased but not to levels that concern police. All complaints should be made to 911.

#### C. Pennsylvania State Representative - Rep. Aerion Abney (Thomas Harnett)

- Budget season is underway in Harrisburg.
- Rep. Abney is working on a new state tax credit for federal EITC recipients.

## D. City Planning Department (Nazia Tarranum)

- Ms. Tarranum did not attend the meeting.

## E. Pittsburgh City Council District 1 – Clr. Bobby Wilson (Jordyn Gilliard)

- Park pathway improvements will cost six figures. She recommends AWCC and ACI make a budget request.
